## 2. NEW BUSINESS

 a. Human Resources Update - Darrell Easley, Director of Employee Relations & Learning and Organizational Development

Staff performance evaluation season is here. Annual Staff Performance Reviews for 2023 are due March 31, 2024. There are several workshop support sessions, hosted by Employee Relations, on different topics surrounding performance reviews, for both managers and employees. Our Knoxville Campus Human Resources department is involved in the implementation of <u>DASH</u> (Dynamic Administrative Systems for Higher Ed), the University's new ERP (Enterprise Resource Planning) system and several of our teams have been in meetings for early testing of the system. The new system is scheduled to be implemented July 1, 2024. Training is slated to begin around April/May 2024.

The HR Career Development and Recruitment teams have a couple of upcoming events. In March, the HR Career Development team will host an event called "Connect the Dots," which will be a professional development event for people to network informally. The HR Recruitment team will hold an internal job fair in April. More information to come on these events.

# ii. Employee Relations Advisory Board

The Employee Relations Advisory Board (ERAB) met on December 20, 2023. The meeting opened with President Boyd giving remarks on a wide variety of topics. David Miller, Sr VP & Chief Financial Officer, presented on the Employee Engagement Report and gave a status report on DASH. Dr. Izetta Slade, Executive Director of HR/Employee & Organizational Development, presented on the annual performance review for staff and stated that process will roll out in DASH beginning in 2025. She also spoke about how scores are perceived and how the Be One Values will be incorporated into the staff review. Dr. Slade also shared the Diversity, Engagement, and Inclusion review category will be folded into the service and relationships category beginning in 2025.
